3. Trailers will not be issued until payment is received.
4. The above church representative agrees that the **\$100 deposit will be refunded ONLY** when the trailer and its contents are returned **clean and in proper condition** and the keys turned into office.
5. The Block Party Trailer will be returned to the proper location by 12 noon of the first business day after the above stated date of event. *(Example – if event is on the weekend, return by 12 noon Monday).*
6. The above church assumes full responsibility for the trailer while on their site. This includes flat tires or blowouts. Any damages to the trailer or its contents will be reported to the Three Rivers Baptist Association upon return of trailer. **Three Rivers Baptist Association assumes no liability for injuries or damage due to the use of the trailer.**
